According to PA Puppy Lemon Law If registerable, papers must be provided as soon as the seller gets them from either the Registry or the Breeder within 120 days from today. After that if Buyer chooses 50% refund, Registration papers will not be given \_\_\_\_\_

I/We have been told about the "Puppy Lemon Law" and received a notice from the Seller given by the Attorney General's Office regarding the law. The Seller is entitled to a second opinion from a licensed veterinarian of Sellers' choice at Seller's expense. \_\_\_\_\_
